The assessment of the mission abroad will be carried out in view of the following:

• The assessment form (learning agreement document) which must be filled in and sent by the person in charge of the foreign company (local tutor) (50 %).

- The evaluation grid completed by the school which will be based on:
 - Report submitted by the student in English (25 %)
 - Presentation in English (25 %)

The student must have passed all three of the above-mentioned parts.

Argibideak/Aclaraciones/Explanations:

Both the report and the oral presentation will be assessed by the Mission Abroad board composed of the person responsible for the promotion and the teacher in charge of teaching the English subject or persons delegated by them. The evaluation will be based (as long as the minimum stay of 10 weeks is fulfilled) on the evaluation of the tutor of the foreign company, the report of the stay and an oral presentation.

EZOHIKO DEIALDIA - CONVOCATORIA EXTRAORDINARIA – EXTRAORDINARY CALL

The weighting of the sections will be the same as in the ordinary exam.

- In the event of failing the report and/or the presentation in the ordinary exam, the student will have to repeat them in the extraordinary exam.
- In the case of an unfavourable evaluation (less than 5.0) in the evaluation form, work will be proposed to pass this section.
